9.1 I received an enquiry from Coventry for any information I might have on a news item they'd spotted on 3/8 which said "Rail chiefs and football bosses are in talks over ways they can help those impacted by games moved for TV coverage" with the full story at [bbc.in/2vhojQt](http://bbc.in/2vhojQt).

I asked Amanda Jacks at the FSF if she had any further details and the reply was not encouraging "In short, I'm afraid I have no news to share with you. While I'd like to spend my time pushing for a railcard the current prevailing agenda being pushed by the Rail Delivery Group, Train Operating Companies and the British Transport Police is tackling behaviour on the rail networks and my involvement is more on that.

While I'm aware the EFL have done a fair bit of work in recent years in pushing for a railcard, to be frank I can't see any progress in terms of better deals for fans any time soon."

9.2 Neil then lead a discussion at the meeting, points being made that the train operating companies, rather than trying to generate income from travelling football supporters, seemed more intent on making travel as difficult as possible for them, the Chester representative being amongst those to echo this view.

### 10.3 Darts

10.3.1 The draft fixtures and other proposed dates during the season (eg the pairs and singles knockout competitions) have been sent out to team contacts. The season doesn't formally get under way until early October, but to try and prevent the cup competition over running again, I plan to make the draw for both the preliminary round

and the first-round tonight. This means that teams can arrange matches earlier to hopefully avoid a delay this season. I am expecting that all 16 league teams will be entering the cup this season, along with Coventry City and Burnley. Ipswich Town do not know whether they will be able to enter the cup, so I have agreed with them that they will be automatically entered in to the preliminary round. Should they not enter, the team they have been drawn against will be given a bye to the first round.

10.3.2 As agreed at the darts AGM, fees for entry to the league remain at £16 and entry to the cup remains at £12. I would be grateful if teams can arrange to make the necessary payment to the APFSCIL treasurer.

10.3.3 Also, at the AGM, and as I couldn't make August's APFSCIL meeting so wasn't able to raise, but it was proposed that the number of medals for each eligible team, without having to pay an additional amount, should be increased from the current seven, to eight. This would mean that any more medals beyond eight will need to be paid for by the team, and the cost of this will remain at £5 per additional medal. I would be grateful if this could be considered at the meeting.
