6 Secretary's Report.

- 6.1 My apologies for missing the meeting (this is getting too regular!) but unfortunately the FSA have called a National Council meeting for the same time and evening and that does need to take precedence.
- 6.2 I paid the Namesco invoice for the Renewal of apfscil.org.uk for 3yrs from 12 Mar 2023 for £43.99 plus VAT £8.80 so in total £52.79. The Treasurer reimbursed me by cheque.
- 6.3 Chris Learmonth, Hearts, paid out to get the APFSCIL Pool League Summer Cup trophy engraving up to date. It hadn't been done since 2016, but it's now been updated with an extra plate, and the past 6 years therefore the following was added: 2017 Newcastle United; 2018 Middlesbrough; 2019 Newcastle United; 2020 N/A (covid lockdown); 2021 Middlesbrough; and 2022 Exeter City.

The total cost was £52.50, which breaks down to £15 for first line, plus £7.50 per each additional line (x5).

I transferred the money to Chris and the Treasurer will reimburse me with a cheque as usual.

- 9.1 Mark Harper, the Transport Secretary, made his announcement about the new ticketing arrangements and I'm sure we were all impressed I was so impressed I've completely forgotten what he said! Of course, following that the rail fares all went up yesterday!
- 9.2 Whilst we're talking Railways there are more strikes happening as well. In case you've missed them they are on Thursday 16 March, Saturday 18 March, Thursday 30 March, and Saturday 1 April. There is also a Tube strike on Wednesday 15 March.

The following rail operators will be affected by the strikes: Avanti West Coast; Chiltern; Cross Country; c2c; East Midlands; Gatwick Express; Greater Anglia; Great Northern; Great Western; LNER; Northern; Southeastern; Southern; South-Western; Thameslink; TransPennine Express; and West Midlands. TFL, National Rail, and the 14 train companies will provide more information on how services will be affected closer to the time.

- **10 Sports Secretaries Reports**
- 10.1 Pool Report
- 10.1.1 The new league season is finally underway, and we held an AGM via WhatsApp to ensure that all 10 teams could participate. Fees were accepted at £20 for the year if there are any teams who are not paid up within a reasonable period, please could the Treasurer let me know and I will chase.
- 10.1.2 There was a minor rule amendment from the "Old EPA" playing rules that we have been working with previously which was passed to further clarify the situation where a ball or balls of one colour group are potted off the break, with the player allowed to opt to play the other colour group from the shot immediately following the break if they choose to do so.
- 10.2.3 The intention is to complete the league season (9 games per team) by the end of July. The updated League rules are attached, please could these be added to the APFSCIL website?
- 10.2.4 It's my intention to develop our own pool league website (away from the current League Republic platform) where we can better manage our data, maintain personal

statistics as well as team ones, etc, but that's a relatively long-term plan at the moment.

10.2.5 For completeness' sake the final of the 2022 Clydie Weekes Summer Cup competition took place on Tuesday 7 February at the Brewery between Exeter and Sunderland. The match went one way then the other, 0-1, 1-1, 2-1, 3-1 3-2, 3-3, 4-3, 4-4, and finally 5-4 going down to the wire with Exeter potting the black whilst a Sunderland only had one ball left. As stated above the Trophy was updated and has been passed to Exeter to hold until the next final.
